General Terms & Conditions

1 June 2023

The following terms and conditions govern your use of the platform, solutions, products, mobile software, and other software provided on or in connection with the applications, website and services collectively known as "Services" made available by Tagy Tech Sdn. Bhd. 201901011249 (1320577-X) a private limited company established in Malaysia, having it's office at Unit D-3-4, Level 4, Block D, Setiawalk, Persiaran Wawasan, Pusat Bandar Puchong, 47160 Puchong Selangor DE, Malaysia, hereinafter referred to as "Tagy". These Terms apply to all Account Holders, visitors, users, and all others who access the Services.

1. Contractual Relationship

These Terms of Use ("Terms) govern the access or use by you, an individual, from within any country in the world (excluding the United States and its territories and possessions and the People's Republic of China) of application, websites, content, products, and services (the "Services") made available by Tagy.

- 7. Your Use of the Services

User Accounts

In order to use most aspects of the Services, you must register for and maintain an active personal user Services account ("Account").
